## Fee Schedule

### 1. POSIX Trademark License Fees

The fees described below are quoted net of applicable taxes and duties which, where appropriate, will be payable in addition by the Applicant to The IEEE (or to the relevant tax authorities as applicable).

Note that fees are only due for applicants who wish to license and use the POSIX trademark in association with certified products. There are no trademark fees associated with certifying a product and appearing on the Register of Certified products.

Special Registration (Restricted Country) License Fee per Restricted Country, please see TMLA Schedule 2, Section 2 for list of Restricted Countries	\$2,200	Upon Licensee's notification of intent to use, but prior to actual use of certification mark in a Restricted Country
